A new release of Customs and Border Protection's program called the Automated Commercial Environment, or ACE, has created an additional workload for carriers. This new release of ACE mandates the electronic filing of manifest information prior to arrival at the border.

IS IT SAFE TO LEAVE?



The time between filing and arrival at the border varies

- 30 minutes for FAST trips
- 1 hour for normal trips
- 2 hours for FDA trips
